As I have said many times, the UMKC School of Dentistry could not achieve the success we do without the generous support of our alumni and friends. That support allows us to not only sustain our level of excellence day-to-day, but also enables us to position ourselves to remain excellent in the future.

t goes without saying that our students are the focus of nearly everything we do: teaching and learning, research, and caring for our community. Every member of our staff, faculty, and student body contribute to our mission of preparing the best dentists and dental hygienists for the future of our profession.

You, too, play a vital role in helping us support student learning! In order to position ourselves as a cuttingedge dental education institution of the future, we have selected as one of our priority projects the creation of a state-of-the-art skills laboratory (or pre-clinical laboratory). I have previously communicated our plans to outfit our present bench-based labs with sophisticated patient simulation operatories (see image below). I would like to reiterate that this project is vital to the future effectiveness of our students' mastery of clinical skills because it will allow us to utilize ultramodern equipment that is quickly becoming the industry standard. The units will provide our students an authentic learning environment early on that better simulates the ergonomics, patient positioning and operatory instrumentation that they will encounter during their third- and fourth-year patient-based clinical experiences. Each patient simulator can be tied to a "patient" record with a treatment plan that students will work through to gain mastery and achieve competency. It is time for us

to move our pre-clinical laboratory to this "teaching/learning format of the future." Newly constructed or renovated dental schools are incorporating this technology in their skills labs, and candidates for dental school are now looking for this type of equipment and learning environment.

When the dean envisioned a whole new lab experience, one with real-to-life interactions involving ergonomics — the opportunity to position a patient and a feeling of authenticity — it was clear the School of Dentistry was entering a new chapter of innovation and clinical excellence.

We knew this was a project our alumni would be excited about. What a big leap forward to move from "heads on a stick" to simulated patient interaction. This will be more than individual skills assessed in a vacuum, and our graduates will be better for it. And we were right, alumni are excited! So excited they want to be partners and be a part of a new era. Jerry Ogilvie (DDS '73) and his wife, Annie, were the first to step forward and commit to purchase a simulator unit. With his knowledge of student skills in our AEGD program, Dr. Ogilvie saw what a large impact this project will have on student success. They both believe in it so much they wanted to help make it a reality.

When I returned to the School of Dentistry after 40 years in private practice, I was surprised to see that our pre-clinical training labs are essentially unchanged since my days as a student. Many other dental schools have more modern pre-clinical facilities. As a graduate instructor, I have seen this first-

hand. It's evident to me that our School needs to catch up and keep up. We're in competition with other dental schools for excellent students.

That's the reason Annie and I pledged to support the purchase of a new dental patient simulator. My career began at UMKC and put our family on the road to a successful and rewarding life. We want our future graduates to have that same opportunity.

My Alumni Story

graduated right before the stock market correction of 2008. At that time the Kansas City Royals were terrible and my credit-to-debt ratio was equally horrendous. I was transitioning to private practice quickly, working in my hometown of Blue Springs, Mo. I was challenged with interviewing new staff, acquiring new dental materials, using different and newer machinery and having a life outside of dentistry. It was thrilling to practice dentistry, but other facets of dentistry were foreign to me. When I walked out of dental school and treated my first few patients in the real world, I

wanted someone to check my work. I had grown accustomed to someone knowledgeable watching over and helping me when anything was out of the ordinary.

The transition from graduation to practice was rapid. I was now supposed to be the smartest guy in the room. My colleagues at the office were experienced dentists, and they helped guide and mentor me into the practice. I was able to observe two completely different practice styles but still envision the type of practice that I was hoping to create. UMKC taught me what to look for, what to avoid and what to be skeptical of clinically. The curriculum provided me with the basic information I needed to practice, but interactions with faculty is where I gained my most lasting knowledge.

I appreciated hearing differing viewpoints from faculty as this was transformative in seeing a professor's inner thoughts versus a general directive. The professor's background, skills, strengths and personality could be

perceived when a treatment plan was rendered.

In my early days as a new dentist it was comical dealing with new staff and trying to use new materials and equipment. How long should I schedule a crown prep? "No idea," I would say. "They gave me three hours to accomplish it in dental school and three hours to do the build-up."

My frame of reference for timing procedures was skewed initially. In preparing for private practice, most conversations revolve around how you would treat one situation, or how you would approach this patient's care — not as much about

how to delegate staff and time. UMKC provided me with a base of dental knowledge, and I was now combining that with managing my own practice and staff. Honestly, much of the learning process as a new dentist was taught through experiences with patients and conversations with other dentists.

Though my career has been short in nature compared to some, I have experienced many positives, challenges, and growth as a practitioner. Dentistry is now digital, more mechanized and should be more precise and repeatable. This doesn't mean it is easier but that it has changed how I treat patients. In my office I have two colleagues that I am able to share my successes and failures with. We learn from one another and this translates

into success and humanizes our professional peaks and valleys. As we were taught in school, each patient and situation is unique; I have found that to also be true

It can be refreshing to share these challenges, so you don't feel alone in your experiences. Practicing dentistry has been a rewarding career for me, but not without some growing pains along the way. I am thankful for my education at UMKC, as I learned more than just dentistry during my four years.

Dr. Lynda Bonewald Receives National Award



Dr. Lynda Bonewald, UMKC Curators' Professor and director of the UMKC Center of Excellence in the Study of Dental and Musculoskeletal Tissues (UMKC CEMT), has long been recognized as one of the world's leading bone scientists; now that reputation has received special recognition from the American Society for Bone and Mineral Research. The organization presented Dr. Bonewald with the William F. Neuman Award, its oldest and most prestigious recognition, at its annual meeting in October 2015 in Seattle, Wash. The award honors outstanding and major scientific contributions to associates and trainees in teaching, research and administration.

"I am very happy to be receiving this award, but at the same time I am humbled to be joining the leaders in our field who have received this award before me," said Bonewald, a past president of the society.

In 2012 UMKC received a five-year, \$8.3 million grant from the National Institute on Aging, part of the National Institutes of Health, to study the relationship between osteoporosis (loss of bone density) and sarcopenia (loss of muscle mass) as people age. The research is led by Bonewald and conducted by a multidisciplinary team of investigators from UMKC's Bone Biology and Muscle Biology research groups, part of the CEMT.



DH Grad Student Wins National Poster Competition

Danette Ocegueda's poster "Cultural Diversity in Dental Hygiene Curricula" took first place at the Dentsply Graduate Dental Hygiene Research Poster competition at the ADHA meeting in Nashville, Tenn., June 18, 2015. 
Dr. Linda Sturrup Publishes Second Children's Book

Area Researchers Form Consortium to Study Musculoskeletal Disease

In February 2015, after two years of planning, the Kansas City Consortium on Musculoskeletal Diseases and Disorders (KCMD) was born. The consortium brings together scientists and resources focused on the research of musculoskeletal disorders and diseases at the UMKC School of Dentistry, the Kansas City University of Medicine and Biosciences (KCU), and the University of Kansas (KU) Medical Center. This is the first formal agreement to conduct joint research between the health sciences schools of these three universities.

This initiative is the first of its kind in Kansas City and provides opportunities to combine the individual strengths and resources of the three health sciences schools to advance translational research.

Sometimes referred to as "bench to bedside," translational research harnesses knowledge from the study of basic sciences to produce new drugs, devices and treatment options for patients. The goal of the partnership is to build medical research teams that will concentrate on ways to prevent and treat diseases of muscle, including neuromuscular disease and mineralized tissue, which includes teeth, cartilage, and bone. Not only could findings be applied to drugs, biomaterials and composite research, medical devices, diagnostics, and clinical imaging, but can also be

expanded to veterinary practice and the diagnosis and treatment of animal dental and musculoskeletal disease.

The consortium is overseen by an executive committee comprised of Jeffrey Joyce, PhD, vice president for research at KCU; Richard Barohn, MD, vice chancellor for research at the KU Medical Center; and Lynda Bonewald, PhD, a UM Curators' Professor at the UMKC School of Dentistry. Dr. Bonewald has stepped down in her capacity as vice chancellor for translational and clinical research at UMKC in order to serve

as the founding director of the

consortium. The directorship will rotate between each of the institutions every three years.

Dr. Bonewald also serves as the director of the UMKC Center of Excellence in the Study of Dental and Musculoskeletal Tissues (UMKC CEMT), which will be the major UMKC component of the

UMKC CEMT is composed of investigators from the Schools of Dentistry, Nursing, Medicine, and Computing and Engineering. UMKC's dental and mineralized tissue research programs are recognized nationally and internationally and have researchers with long histories of competitive



support for their work.

"The goal of this consortium," says Dr. Bonewald, "is to build powerful research teams of basic to clinical investigators from our three institutions to discover new treatments and cures. These research teams will give our students opportunities to work alongside the researchers to understand and optimally treat musculoskeletal disease."

The consortium has already formed a team to study bone regeneration/ infection and another team to study ALS (Lou Gehrig's disease). A grant application has been submitted to the National Institute of Health for support of core facilities at UMKC and KCUMB.

The members of the External Advisory Board include: Dr. Paul Terranova, former vice chancellor for research at KU; Dr. Rob Krumlauf, scientific director of Stowers Institute for Medical Research; Dr. Wayne Carter, CEO of Kansas City Area Life Sciences Institute; and Dr. Roger Harris from MRI Global.


with the Venturini team.


