### MESSAGE FROM THE DEAN

It is a great time to reflect on an important legacy at the School of Dentistry that began with an extraordinary leader, Dr. Roy J. Rinehart. Few would disagree that this man had an indelible impact on the history of the School. Known for his acts of personal kindness to students and faculty, Dr. Rinehart established an impressive legacy that we benefit from every day.

Dr. Rinehart expressed the following thoughts at a testimonial banquet in his honor in 1946:

The greatest hope for the dental [community] in these troublous times especially and in fact, always lies in the closest cooperation, the most implicit confidence, and the highest degree of solidarity of aims and principles among our members. These things are possible only if every one of us conducts himself at all times with the most meticulous professional courtesy, based upon the altruistic desire that the greatest good may accrue to the greatest number.

Dr. Rinehart's words remain apropos today and would squarely align with contemporary views on great leadership and followership attributes. But he did more than speak wisely and act kindly. He selflessly put his commitment to the future of the School into action by securing its stability, its identity. Through his work, the School grew in size and quality while he advocated for the need to be part of a great university. He advanced the School from a for-profit apprenticeship program to one that has a scientific basis and belongs in an academic setting at a university. After Dr. Rinehart's death, friends, faculty and alumni chartered the Dr. Roy J. Rinehart Memorial Foundation in 1957 to continue his dreams and ambitions for the School, including raising funds for a new building that he had so passionately championed.

His actions, six plus decades ago, were committed to one mission: the future of our dental school. We continue to remind ourselves that our work is continually focused on that purpose: One Mission, One School! Dr. Rinehart created a founding legacy that today lives on in perpetuity in the Rinehart Foundation. Our students, faculty, staff and patients reap the benefit of the ripple effect of his tireless energy, commitment and resolve to make the School of Dentistry the best dental education institution in the land.

This fall, through ongoing generous contributions to the Foundation by friends and alumni, the School awarded approximately \$900,000 in scholarships to our students! The Foundation also continues to assist the School by supporting special projects such as faculty positions and vital programming. It is with the deepest respect and gratitude that I thank our predecessors and contemporaries, because they and YOU continue to make great things possible for our School.

As we look to UMKC's future, we will embark on important initiatives that continue Dr. Rinehart's legacy of kindness and service. I hope you will help us continue our journey, enmeshed in Dr. Rinehart's legacy of One Mission, One School. Our future depends on it!


# A Ripple Becomes a Wave Thanks to You

# Remembering Dr. Rinehart

Friend and Father Figure to All

The number of people who knew Dean Rinehart is dwindling, but if you were fortunate to hear stories from those who knew him, you would have discovered that everyone recalled him with as much reverence as affection. Ralph Lopez (DDS '37), who arrived at Kansas City-Western Dental College in the 1930s from New Mexico, wrote this remembrance in 1987.

I reported to Miss Potts on the first day of school. She worked for Dr. Rinehart as his personal secretary for over 40 years, and each and every student was her friend. She introduced me to Dr. Rinehart, and he said, 'Young man, we are glad to have you with us, but I do not know what I am going to do with you. Miss Potts tells me you don't have any money except \$18.00. How do you expect to pay your tuition of \$250 per year?'

Dr. Rinehart was not a large man, medium size, maybe on the short side, but taller than me, round, even his face was on the round side; but all of his time was yours. He was full of kindness, and he had a very gentle, soft manner, pleasant voice, slow and articulate. He asked me about my

family. [After telling him my story] Dr. Rinehart called Miss Potts and said, 'Get this young man a place to stay in one of the boarding houses close by. Give him \$25 in cash to pay his board and room for at least two weeks, and then we will decide what to do with him. Have this young man come in tomorrow at noon and put him to work.

Before I left the school at the end of 1937, Dr. Rinehart called me in and we had a wonderful visit. He said, 'You will hear from me once a week, probably on Friday, because there are going to be a number of things that you will be doing for me.' And for the next twenty years we had a long chat every Friday and saw each other many times until he passed away in March 1957.

## Remembering Dr. Rinehart

A Lasting Legacy

**Upon Dean Rinehart's** unexpected death on March *22, 1957, Dr. Joseph Jacobs* became acting dean of the school. One of his early acts as dean was to work with alumni to establish the Dr. Roy James Rinehart Memorial Foundation. *Articles of incorporation were* filed May 26, 1957, stating that its purpose was, in part, "To honor and recognize suitably the achievements and contributions of the late Dr. Roy *James Rinehart to the University* of Kansas City, its School of *Dentistry*, *dental education* and research, and the dental profession." The Foundation *quickly received more than* \$75,000 in donations to honor Dean Rinehart's legacy. Today the Rinehart Foundation, through the generous donations of the School's alumni and friends, provides invaluable support to the School's mission of achieving excellence in dental education, research, service and clinical care, and strives to use its current \$23 million dollar *endowment to continue Dr.* Rinehart's legacy.



# Remembering Dr. Rinehart Partners in Progress

It has been said that behind every great man is a great

woman. That was certainly true for Dr. Roy Rinehart and his wife, Myrtle. His dedication to ensuring the dental school's survival and excellence were echoed by Myrtle. As dean, Dr. Rinehart was not only an accomplished clinician, but an astute businessman as well. His business acumen also served the Rineharts well as they built a successful sideline in real

estate. As part of that venture, Myrtle designed houses as a hobby, and Roy built them. Over the decades, their financial resources were always at the disposal of the school. When Myrtle died in 1972, she once again demonstrated her lifelong devotion to the School when she bequeathed the entire dental hygiene students at the Rinehart estate to the UMKC School of Dentistry. Today, the legacy of that bequest lives on in the Myrtle Rinehart Scholarship fund, which annually awards financial

support to dental and dental hygiene students. Another lasting legacy of the Rineharts is the Rinehart General Scholarship, whose charter states, "The various donors have many affiliations with the School, but their purpose is one — to assist dental and UMKC School of Dentistry with reaching their educational goals."

Sarah Dallas, Ph.D., the Lee M. and William Lefkowitz Endowed Professor, will be featured in an eight-episode documentary on the human body. A five-person crew from the Japanese television network NHK interviewed her for the show's episode on bone. Dr. Dallas is a pioneer in the imaging of osteocytes, specialized cells embedded in the bone. Dallas is a key member of UMKC's research team exploring osteocytes and how they degenerate as aging occurs.



**Jeff Gorski, Ph.D.**, professor of Oral and Craniofacial Sciences, along with a group of international coauthors, published "Bivariate genome-wide association meta-analysis of pediatric musculoskeletal traits reveals pleiotropic effects at the SREBF1/TOM1L2 locus" in the July 25, 2017, edition of the journal Nature Communications. "I was pleased to be part of the larger study," said Gorski, "because the outcome provides strong support for a functionally important role for the gene SREBP1 in bone and muscle. Having received encouragement for a role for SREBP1 in determining muscle mass and bone density, we can pursue more focused studies to increase muscle or bone in aging human populations where these tissues are subject to sarcopenia and osteoporosis."



Dr. Behjet Moghadam, retired faculty member of Restorative Clinical Sciences, was granted the title of Professor Emeritus by UMKC Chancellor emeritus, Leo Morton. Dr. Moghadam, who joined the faculty in 1987, continues to serve as an adjunct faculty member.



Dr. Shankar Rengasamy Venugopalan, assistant professor of Orthodontics and Dentofacial Orthopedics, was recognized as one of the "Top Reviewers of 2016" by the American Journal of Orthodontics & Dentofacial Orthopedics. His application to the UM Faculty Scholars program was accepted for the 2017-18 session.





Dr. Jim Trotter, assistant clinical professor in Restorative Clinical Sciences, and **Keyna Chertoff**, senior research assistant in Dental Public Health & Behavioral Science, recently completed the year-long Oral Health Kansas "Dental Champions Leadership Program." During the program, members worked together to create strategies on how to improve fluoridation in Kansas. They presented their plan to the OHK Board Members at their quarterly meeting, which was followed by a graduation.



**Dr. Rebeca Weisleder** completed the requirements for Board Certification as a Diplomate of the American Board of Endodontics. She is the fifth full-time faculty member to be board certified within the UMKC Department of Endodontics. Dr. James Blundell, chair of UMKC Endodontics, remarked, "To my knowledge there is no other endodontics department in the world with five full-time board certified endodontists."



# Remembering Dr. Rinehart

A Tale of (More Than) Two Schools





### Western Dental College

A 1902 graduate of Western Dental College, Dr. Rinehart joined its faculty in 1913, which also happened to be the year its founder and head, D.J. McMillan died. The college began to struggle, so Dr. Rinehart and a group of investors bought it. In order to improve the quality of dental education in Kansas City, Dr. Rinehart helped bring about the merger of his institution and its rival, the Kansas City Dental College, thus forming the Kansas City-Western Dental College in 1919. Then in 1920 he personally helped finance the construction of a brand new building at 10th and Troost, which housed the school until its present home opened in 1970. His commitment to improving the quality of dental education continued in 1922-23, when Dr. Rinehart transitioned the school from a commercial institution to a non-profit corporation held in a public trust.

### **UMKC School of Dentistry**

Thanks to Dr. Rinehart's unwavering dedication and leadership, his beloved institution successfully negotiated the long and winding road that led to the formation of today's UMKC School of Dentistry. As dental education evolved in the early twentieth century, pressure mounted to move away from privately owned training institutions and toward university-affiliated professional schools. Dr. Rinehart embraced the idea, but faced a daunting challenge: Kansas City had no university to affiliate with. In the late 1920s, Dr. Rinehart lent his support to the establishment of Lincoln and Lee University, an idea that unfortunately did not survive the Great Depression. Unbowed, Dr. Rinehart responded by championing the formation of the University of Kansas City (UKC), which opened in 1933 and was joined by the School of Dentistry in 1940. As part of that process, Dr. Rinehart canceled all personal loans and debts owed him by the dental college. The UKC School of Dentistry was born. Then in 1963, UKC became UMKC when it joined the University of Missouri System.





# Ten Years of Teamwork with TeamSmile

In 2007 the Kansas City Chiefs hosted the first TeamSmile one-day outreach event in which dental volunteers provided dental care at Arrowhead Stadium. More than 100 hundred children were screened, treated and educated on the importance of oral health that day. UMKC School of Dentistry student and faculty volunteers were there to lend a hand, and they are still helping 10 years later. Today TeamSmile's outreach and UMKC's participation have expanded to include events with the Kansas City Royals and Sporting KC.

"In preparation for the inaugural event in 2007, Dr. Bill Bush, a TeamSmile cofounder, contacted me to see if the School of Dentistry had any portable dental equipment that he could borrow," recalls Dr. Michael McCunniff, director of the School's outreach programs. "Not only did we provide them with equipment, we also supplied student and faculty volunteers. TeamSmile continues to provide a unique opportunity for our students and faculty to give back to the community by delivering care to children who otherwise might not have access to dental education and care. Just as important, our dental students experience firsthand how to personally and organizationally think 'outside the box' in





order to meet the dental needs of vulnerable populations. At each event, I challenge every student to come up with their own ideas on how to give back to their community and make a difference once they are in practice."

Since its inception, TeamSmile has evolved from an event-driven concept to a formal nonprofit organization dedicated to using the power of professional sports teams to draw at-risk children into their first contact with dental care. TeamSmile now partners with a total of 20 professional sports teams from coast to coast.

# Remembering Dr. Rinehart

Aloha Hawaii

During World War II, when much of the United States was seized with fear of Americans of Japanese descent, Dean Roy J. Rinehart chose to guide the UKC School of Dentistry down a different path. He let it be known that his school would welcome Japanese American students with open arms. That message made its way to Hawaii where a handful of desperately hopeful students decided to take him up on his offer.

George Tanaka (DDS '49) recalled his acceptance letter, "I had tears of joy when a telegram came to me in 1945 saying, 'Come on over —see you September 17. R.J. Rinehart.' To us he was a man who had the foresight, courage, strength and faith to accept us as human beings who are equal." Since the war Dr. Tanaka and equally devoted Hawaii alumni have expressed their gratitude by actively recruiting Hawaiian students to attend UMKC, and the School continues to welcome them as Dr. Rinehart did, with open arms. Today the School has 130 alumni living in Hawaii.
